# **Cresthaven Community Meeting See/Discuss Plans for New School**

Montgomery County Public Schools and architects from Sorg & Associates will present their design plans for the new grades 3-5 elementary school that will replace the current building on Wednesday, June 20 at 7:00 p.m. This is the community's opportunity to see and comment on the design before presentation to the Board of Education for approval in September.

The new campus is being designed with a gym and classrooms for the projected 492 students. The building's core will accommodate up to 640 students with the addition of classrooms as needed. On-site parking for over 70 cars will be provided, as will a separate bus loop with parking. Recreational areas are included.

Construction is anticipated to begin in January 2009 with the opening in fall of 2010. During that time students will attend Cresthaven at the Fairland Holding School.

### **Key Demolition to Begin July 9**

Plans are underway for the demolition of FS Key Middle School to begin on July 9, or shortly thereafter. The demolition will take approximately 10 weeks with construction of the new school to follow. The ball fields will be closed during demolition and construction. The new Key will open in the fall of 2009.

# **Gypsy Moths**

A call has been made about the problem. We were slated for spraying this spring but budget shortfalls put us out of the running. The state is aware of the problem. Most likely they will spray this area next spring.
