

Help Wanted For Hillandale's Corner

The Hillandale wall (officially known as a monument) at the corner of New Hampshire Avenue and Powder Mill Road is a very familiar landmark to all. But, many Hillandalers do not realize that this small green space is a community project with a long history, and deserving of your help.

First—a little history: For many decades the intersection of what is now New Hampshire and Powder Mill was actually a five-point intersection that included Greenacres Drive. In the mid-1960s, Greenacres was reorganized to its current termination at Powder Mill. This change created the little right-

of-way void between the roads. Community leaders petitioned the County for permission to beautify this area and a few years later (after raising funds by holding card parties) completed the effort by constructing the signature brick wall in 1966-67.

For three and half decades, the Hillandale Woman's Club maintained this proud entryway to Hillandale. Every year a new Club Beautification Chair carefully planned improvements and organized volunteers to cut the grass, maintain the flowerbeds and even sweep the street gutters! Over the years cherry trees were planted, then removed, flowerbeds were installed, changed and planted over and over again. During the 1990s, the Club installed white lights on an evergreen tree as a seasonal fundraiser for Montgomery Hospice. But when the Club ended in 2002, so did their official sponsorship of the corner.

HELP WANTED: April through October 2012

Lawn Mowing: Volunteer to cut the grass once per month — that's a "6 mow" commitment. If that's too often, tell us how often you are willing to help. (We need multiple volunteers — so please do help.)

Litter pick-up: Unfortunately, this needs to be done often, so we need a few truly committed folks willing to share weekly duties. And, if interested, this could include removing "Junk Car" signs too!

Flowerbed weeding: Given the weed control fabric and mulch, this is a once per month job for one or multiple gardeners. Water for the beds is available.

Hillandale News Tidbits

Roadside **Solicitation** Legislation: The Montgomery County House Delegates and Senators did not support the bill to give the County the option to enable a permit system or enact a ban. They did support the "permit only" legislation and have sent that on to the General Assembly for final action. Although any permit system will have to be enacted by Council at a later date, the fiscal note accompanying the State legislation indicated that the County anticipates 3,000 permits to be issued requiring three new employees to administer and enforce the system. Council and the Executive will decide details of whether permit holders will be allowed in the roadway, on medians and sidewalks, along with the duration and cost of the permits.

HCA supports Hillandale's Public Schools: HCA allocates funds annually for school support. Recently, awards were made to Springbrook's After-Prom activity, and Cresthaven's PTA to support its outreach activities.

Third District Update: At the January HCA General meeting, Commander Johnson reassured the community that Hillandale is safe and secure.

More recently, it was announced that the new Third District Police Station ground breaking is scheduled for April 12. The new station will be constructed along Milestone Drive to the east of New Hampshire at Route 29. Decisions regarding the excess land adjoining the station will be made at a later date. Proposals for a senior housing facility or a small HHS office have been discussed.

Neighborhood Clean-Up: The HCA Board is considering setting up a Community Clean-Up Day on May 5. There are several areas that are being considered including the wooded area of Hillandale Local Park; the Riggs Court paper road in Hillandale Forest; the vacant lot at Oaklawn and New Hampshire; and the area of the community welcome sign on New Hampshire. If you would like to head up one of these spots, please come to the March meeting and volunteer!


PLEASE STOP putting bagged dog waste in our storm drains.



Some loving pet owner has been depositing bagged dog waste in the storm drains along Sweetbriar Parkway. STORM DRAINS FEED DIRECTLY INTO THE LOCAL CREEKS. Storm drain water is not filtered or processed; it goes to the Paint Branch then on to the Anacostia River to the Potomac and the Chesapeake Bay.

Please properly dispose of your bagged dog waste in your trash container at your home. If you do not want to take the waste *into* your home, keep a separate small garbage container outside just to collect the bags and put this container out on the regular trash pick-up days.

Please stop polluting our waterways and be a responsible pet owner. Please, STOP putting your dogs' trash bags in the storm drains, or tossing the bags into the woods, or on your neighbors' lawns.
