- 1. Introduction & Agenda from Margie Goergen
- 2. Guest Speaker MCPD Vehicle Enforcement considerations
 - Officer Phil Butler from the MCPD Commercial Vehicle Unit spoke regarding the
 considerations and rules for vehicle inspections in Montgomery County, and
 fielded many questions regarding concerns specific to Hillandale -- including
 speeding, large commercial vehicles parked on neighborhood streets, and tractor
 trailers cutting through the neighborhood.
- 3. Guest Speaker Home Health & Environmental Hazards
 - Stephen Boie, a long-time home inspector in this area, provided an informative Q&A session on the most common home health hazards and how to deal with them. His talk focused on the problem areas particular for mid-century homes like Hillandale, and he had plenty of questions from the audience focusing on radon, lead paint, mold, ducts, & asbestos.
- 4. Community Response to racist vandalization at local church
 - Margie spoke about her visit to the church and conversations with church leadership on how the community might help. At the moment they are seeing an outpouring of offers, and didn't quite know what they might need, but will continue the conversation as needs arise.
 - HCA has prepared a letter of support (attached)
 - Montgomery County has introduced a resolution affirming a commitment to inclusion. It recommends calling the police for any acts of intimidation witnessed.

5. HCA Announcements

 The Hillandale Holiday party will be December 4th from 5:00-7:00pm here in the CHI center. It is a potluck, family-friendly event and all are welcome to attend.
 Volunteers are needed to help with setup and cleanup (email programs@hillandale-md.org to volunteer)

- HCA has begun a speeding education campaign to remind neighbors and visitors to drive safer. A host of signs will be placed along streets with speed issues (only with permission of each homeowner) for several weeks at a time. Then moved to other streets. Cresthaven in West Hillandale is the first street to get the treatment, but suggestions for other streets should be sent to programs@hillandale-md.org
- HCA will be mailing out membership drive emails in the coming month. This will be the last chance to update your entry in the 2017 Community Directory.
- The new pavilion at the Hillandale Local Park has opened. HCA is planning a ribbon-cutting social for the spring.
- The county's next meeting on the Short-Term Rental legislation (the "Air BnB" rules) is on December 5th.
- The Coca-Cola plant on Elton has made great strides in reducing the number of big-rig delivery trucks cutting through Hillandale Forest, but it remains a problem. Eileen has notified the major GPS companies that the road is closed to trucks, as most of the remaining offenders are being guided through the neighborhood by their GPS devices.
